AMENDMENT TO DECLARATION

STATE OF NORTH CAROLINA
COUNTY OF ONSLOW

THIS AMENDMENT TO DECLARATION (hereinafter called "Amendment"), made and entered into this the 27th day of June, 2008, by and between OLD STELLA BUILDING CO. (formerly known as Old Stella Building Co., LLC), and ALL PRESENT OWNERS AND PROSPECTIVE PURCHASERS of the property located in Hall's Creek North Section I, recorded in Map Book 51, Page 4, Slide L-1341 and Hall's Creek North Section IIA recorded in Map Book 52, Page 159, Slide L-1734;

WITNESSETH:

WHEREAS, the map of Hall's Creek North Section I depicts Lots numbered 1-44, inclusive, and the map of Hall's Creek North Section IIA depicts Lots numbered 45-62, inclusive, 67-76, inclusive, and 134-140, inclusive; and,

WHEREAS, those Lots are subject to the Declaration recorded in Book 2664, Page 412 and the Declaration of Annexation recorded in Book 2807, Page 155 (hereinafter collectively referred to as "Declaration"); and,

WHEREAS, the parties desire to amend the Declaration referenced above in the manner hereinafter set forth. As provided in Paragraph 14 of the Declaration, the restrictions contained in the Declaration may be amended at any time in full or in part by an instrument executed by both at least sixty-seven percent (67%) of the owners of the Lots and by Declarant, which instrument is recorded in the office of the Register of Deeds of Onslow County. The parties executing this Amendment are the owners of at least sixty-seven percent (67%) of the Lots and the Declarant.

NOW, THEREFORE, for and in consideration of the premises and in order to amend the provisions of the Declaration referenced above, the parties hereby do agree as follows:

- 1. The provisions of the Declaration providing for the collection of an annual general assessment and the budgeting and other activities required to impose and collect the annual general assessment hereby are deleted and shall be of no further force or effect. The expenses of the Corporation, including, but not being limited to the expenses required for the proper operation, management and maintenance of the Stormwater Management Facilities, the North Carolina Sedimentation and Erosion Control Permits, the Entrance Sign and the Corporation shall be paid by special assessments, after following the procedure for the levy of special assessments as provided in the Declaration. Special assessments may be levied against the Lots for any of the reasons which.
- 2. The Declaration hereby is amended to provide that the Declarant reserves the right to subject the Lots encumbered by the Declaration to a contract with Progress Energy or other utility provider to provide electricity for the illumination of the Entrance Sign and to a contract with the water provider to provide water to irrigate the Entrance Sign vegetation, either or both of which contracts may require the owner of a Lot to pay a continuing monthly payment for such services.
- Except as hereinabove amended, each and every other provision of the
 Declaration and the Declaration of Annexation is ratified and affirmed.

References herein to Books and Pages are to Books and Pages of documents recorded in the office of the Register of Deeds of Onslow County.


